CEO

Membership is going very well this year. As of close of play on Friday we had just short of 18,500 members. The CEO took the opportunity to thank all the girls in the office for the hard work they have put in, in turning the membership around so efficiently.

One of the developments this year is that we have moved from tractor-feed stationery to laser-printed membership cards, which means it is much quicker for us to process. We invested a reasonable sum of money in a high output laser printer which has reduced printing time considerably.

We are up and running and using the new database. There are still a number of features which we are not yet using to full potential but we are using the elements of it required to process membership, which is working reasonably well.

Since the last meeting a delegation made a visit to RAF Cranwell to hand over our cheques to the Benevolent Fund from proceeds from the various National competitions.

All the bookings submitted for the use of Barkston for 2009 have been approved.

The AGM went very well. The ballot arrangements for this year worked particularly well with the printing of the forms and the running of the ballot being contracted out to Electoral Reform Services.

The planning appeal mentioned earlier in the meeting has been set for 6th March and he would be reporting on the outcome at the next meeting.

We are in the final stages of talks with a new sponsor for Flight Challenge, who is coming on board for 2009 and hopefully in the future also.

The CEO handed round a prototype 'Dart' incorporating details of the new sponsor.

The Development Officer has been working for some considerable time cultivating links with the Royal Navy which have finally come to fruition. They are looking at a substantial level of sponsorship and also the use of their extensive PR and advertising mechanisms.

Hopefully there will be some representation by Senior Naval Officers in their uniforms at the Flight Challenge this year. There is also the possibility of them flying in one of their Merlin Helicopters for the children to have a look at. This is obviously subject to approval of Duxford.

A date has not been formally set for Flight Challenge with Duxford yet.

Royal and Sun Alliance have agreed sponsorship again for University Challenge for 2009 however they have said it would be the final year. We are in negotiations with an alternative sponsor for this event.

The CEO was contacted by David Lloyd-Jones with regard to all the archive plans that are now under the ownership of My Hobbies. David Lloyd-Jones explained the position with regard to the future of these ~~ex~~ X-list plans and whether there is anything the BMFA could do to ensure that these plans, which are in effect our heritage, live on.

Council were in agreement with the sentiments expressed by the CEO, that we would not like to see anything happen to the plans however they do belong to somebody else and we have no legal right or entitlement to them.

The Archivist volunteered and Council were in agreement, that she approaches My Hobbies to ascertain if they would be willing to donate the plans.

London Area asked the CEO whether there was an increase in receipt of ballot papers this year. The CEO confirmed that we received 1,683 returns, compared to just over 200 the previous year.

Council were informed that one of our respected Fellows, Mr Laurie Barr, took part in a television show The Weakest Link, which is scheduled to be screened on Friday 23rd January at 5.15pm on BBC1.

North West raised a point that if there is anything of interest to do with aeromodelling / aeromodellers worth noting that Council are kept informed.

The CEO suggested that the main source for information is the website. If anybody has any information they feel is worth publishing they should let him know and it could be placed on the website.

Chairman

The Chairman reported that the CEO had covered most things with which he has been involved conjointly.

The AGM was the main item he was involved with, all of which he thought was a complete success. He had received a very positive response. He took the opportunity to thank everybody involved for making it such a success.

A question was asked why the venue is being changed for the 2009 AGM. It was explained that there were several reasons why we took the decision to re-locate but mainly because we require more space to accommodate the increasing numbers who attend the dinner and prize-giving.

The visit to Cranwell to present the cheque for the RAF Benevolent fund went very well and hopefully has gone some way to cementing our relationship with the relevant personnel and will help with future negotiations for use of Barkston Heath.

577/01/09 (13) To receive a report from the Vice-Chairman.

The Vice-Chairman reported that he thoroughly enjoyed carrying out his duties at the annual dinner and prize-giving. He thought the atmosphere in the evening was very positive and enjoyable. What is a lot of hard work for people behind the scenes was well rewarded by the reactions.

He attended the annual meeting with the CAA in December. One of the issues discussed at the meeting which he had some involvement with was the aerotow regulations.

It raised an issue of a 'grey area' of non-regulation for gliders between 20 and 80kg. This would be covered in more detail in the Technical Secretary report.

There was also a debate about a known member of the LMA who was circumventing the exemption process and what could be done about it.

More particularly he wanted to highlight that there was a suggestion from the CAA to introduce some kind of financial transaction for the issuing of Exemption Certificates for events.

Their suggestion was that there should be some factor of the public entry **entrance** fee. We feel that is not the way to go and it has been referred back to us to come up with some tentative ideas as to how we should meet the request.

We will be discussing the matter and will take our findings back to the CAA in December 2009.

He also attended the first meeting of the SFTC and was appointed as Treasurer.

There was a meeting of the Safety Review Committee which he was unable to attend. Peter Christy deputised as Chairman of the meeting.

A full report and action points were produced from the meeting and were distributed at the AGM. Copies are also available today if anybody would like one.

One of the topics discussed at that meeting was safety issues at events. It was felt that in the interests of safeguarding the financial interests of our organisation and the level of its insurance premium, procedures should be put in place, which has resulted in the following proposal submitted by the Vice-Chairman.

That the BMFA Development Officer be given the authority himself, or via delegated experienced observers, to attend a BMFA Club, Area or affiliated bodies events to observe that such events, insured by the BMFA, are conducted at a satisfactory level of safety so as to ensure that the BMFA insurance arrangements are safeguarded. The observer should report the findings to the BMFA Executive with recommendations as appropriate. If of sufficient concern, the observer is empowered to make recommendations to the event organisers while at the event. Such visits may be either with or without notice.

The Technical Secretary emphasised that this proposal only applies to events that the BMFA are sanctioning and therefore insuring.

The Technical Secretary commented that we have a very good set of rules, and guidelines for organisers to follow.

The problem in many cases is that they are not being followed. It is not up to us to put more rules in people's way but if organisers are not following the regulations and guidelines laid down by the CAA, how can we answer an insurance query if there is an incident at one of the events.

This proposal is the only leverage we have, which will show the Contest Directors that if they do not follow the guidelines, insurance may not be given.

Peter Christy said he wanted to stress that the main area of concern raised at the Safety Meeting was in relation to large public events, where there is a lot of demonstration flying taking place and some large or fast models being flown and there is an element of risk involved if they are not conducted properly.

The two main observations emanated from the debate were: Should it apply to public and large events only; Should there always be prior notification.

The Vice-Chairman commented that the pure intention is that it should safeguard the financial interests of the membership by not jeopardising the insurance process. That is the only leverage we have.

Peter Christy advised that the issue was raised at the Safety Meeting as a result of several emails he had received from members of the BMFA who were concerned about flying they had seen taking place at shows. In view of that it seems only sensible that some sort of action needs to be taken to prevent reoccurrences.

The Archivist informed the meeting that the cabinets we had commissioned to house the newly obtained Yulon and Mills engines donated from Bud Brautlecht, are now in our possession and available to have a look at if anybody felt inclined.

The Archivist made a plea for more money, more space, more time and more help.

Indoor offered his help. He also advised that he had copies of the 1965 Nationals at RAF Euston which he would send to the Archivist.

He brought to the notice of the meeting the document he had circulated, the 'Code of Practice for the Operation of Gas Turbine Powered Model Aircraft' and referred to a section of the document which he believes requires a change of wording. It includes a proposal to change the wording together with his reasoning for the change.

Current wording:

B.2.2.2

In the event of loss of signal the failsafe must be set so that, after a maximum of 3 seconds the engine will go to idle or shut down. The use of idle as the failsafe setting must be authorised by the event organiser. The event organiser may also specify a shorter delay time.

The Technical Secretary proposed that the current wording for B.2.2.2 noted above be itself replaced by the following:

B.2.2.2

In the event of loss of signal the initial failsafe setting must be that the engine will either go to idle or shut down, depending on the pilot's wishes.

If the engine is set to idle on initial failsafe then, after a maximum of 3 seconds, the engine may either remain at idle or shut down, depending on the requirements of the event organiser.

However, the use of idle as the 'post 3 seconds' failsafe setting must be authorised by the event organiser. The event organiser may also specify a shorter delay time.

The RAeC delegate highlighted some of the points in his written report.

All of the submissions from the BMFA for RAeC Awards have been accepted.

In order both to be accepted in FAI events and also to be considered for any sort of funding or assistance from UK agencies and authorities, all Associations are advised to accept the principles of the World Anti-Doping Agency (WADA). The FAI has a draft of its anti-doping rules which he has passed on to the CEO.

Control Line believes we should seriously be considering putting in place a policy to cover drug banning in the UK in case the situation arises in the future.

As briefly reported earlier by the Vice-Chairman with regard to Aero-towing exemptions with over 7kg models outside controlled airspace, we are very close to a resolution. We are waiting for CAA approval of the modifications to the document submitted by us.

This will then give us the power to be the 'Agent'. It is fairly clear that the CAA is wary about making prosecutions unless they have 'cast iron' cases. However we have put a case before them and it is possible they will be taking action.

Also discussed at the CAA meeting was Gliders over 20kg. We have always assumed that Gliders over 20kg come under Full-size Glider regulations.

However what has come to light is that the EASA regulations only go down to 80kg therefore Gliders in the weight range between 20 and 80kg are effectively still unregulated other than the endangering rules.

With regard to the screening on You Tube of the flying over the Severn Bridge, as previously mentioned the CAA is very wary about making a prosecution without securing a cast iron case for endangering.

The alterations to the ANO with regard to disassociating Sport and Recreation from Commercial data-gathering, has been deferred.

f) Computer Sub-Committee

The map reference section for the new database has now been added. The Technical Secretary said this now enables him to progress the Google map service on the website.

We have been receiving complaints regarding the Classified Ads site. Some people are experiencing problems with registration and are not being given any warnings or explanations. Also that the website was shut down over the Christmas period.

Neither the CEO nor Tech Sec was aware that the Classified Ads site was off-line.

The Technical Secretary explained that some of the problems with registration are that people are trying to register with web-mail addresses. The Terms of Reference (TOR) for the site, which was set in place by the webmaster two years ago, say that web-mail addresses are not allowed.

It is only now that we have appointed moderators who have been sufficiently under pressure from scammers using web-mail addresses we have taken the trouble to take them all off. The situation is that not everybody with a web-based address is a scammer but the majority of scammers have web-mail addresses. We are in a situation where all we can do is remove the web-mail addresses as required by the TOR.

The warning that the TOR was going to be enforced was placed on the front page of the Classified Ads site. The CEO will check out whether the warning does appear on the site. **CEO**

Another problem has been with people having multiple accounts, which also appears in the TOR that this is not accepted.

The PRO advised that discussions at Executive took place about the possibility of introducing alternative means of authentication. This would entail basically linking membership to BMFA number, name, postcode and using that as our master to prove who an individual is. That is the single biggest problem we have. If we can track the person we can deal with their behaviour.

We will be talking to the webmaster in the near future about a security upgrade in the Classified section which will require re-registration of all members. This is not unusual on big security upgrades. This means we will be in a position to say what the registration requirements will be.

The CEO commented that we need to bear in mind that the way the system was set up was to deal with a situation that was in place two or three years ago and the increase in traffic and growth on the classified section has gone up exponentially.

Archivist's Report to the Full Council 10th January 2009

The attached booklet contains most of the things I have archived since taking on the responsibility of the Society's Archivist plus a list of some of the items held by Tim Wescott. I have visited Tim Wescott's home and seen how he is storing these things and I have to say it puts our efforts in the shade.

Included is the archiving of AGM and Council minutes from 1927 to the present day with a few missing, which I hope will come to light in due course. During this time the earlier minute books have been restored.

We have a fairly good collection of the Society's Official Journals, these are being added to on a regular basis they are not indexed, any volunteers will be welcome.

The programme/score book collection starts around 1946 and I am looking out for earlier ones.

Our latest acquisition the Yulon and Mills engines from Bud Brautlecht of the U.S.A. has taken quite some time to authenticate, record, photograph and arrange for display. This was not done by myself alone and we are indebted to Dick Roberts of Market Harborough, Vice President Ron Moulton, FSMAE, Dave Phipps, C.E., Terry Watson, Hon. Mem., Eric Clark, Hon. Mem., Dave Stapleton FSMAE, and Stuart Simpson and the Southern Area for their assistance.

Bud Brautlecht's condition of donating these engines is that they are on permanent display – It is intended that they be displayed in the Conference Room and at the 2009 A.G.M.

During the past six years I have encouraged, cajoled and used what ever means were at my disposal to try to get space for our archives. Currently I have the steel cabinet in the Accounts Office, the wall cupboard in the back room upstairs (used to be the buffet room) and a cabinet and desk in the print room downstairs. This means I am always carrying boxes etc. up and down stairs or taking them home to sort out and then take back to the office and put in the appropriate cabinet. I have to say that all the staff bend over backwards to help where and when they can with the lifting and carrying however, it's not an ideal situation.

Over the years I have been promised various rooms for archives from the original plan , The Tom Whittle Library (Account Office) the upstairs back room (the old buffet room) and I understand from Dave Phipps that in the New Year they are to have a move round and the current print room (the office downstairs to the left of the backdoor) will be the home for the archives only)

Space has always been a problem and possible always will be as we produce archives on a daily basis. We are at a critical time when senior members, who over the years, have built up collections of S.M.A.E. and Aeromodelling archives and memorabilia, they have reached an age when they are looking for a new home for them.

I have been approached by some looking to sell their collections, but many more looking to donate, I am reluctant to accept too many as there is always a cost even if they are donated and I am not aware that there is a budget for this. The Chief Executive, Dave Phipps holds the budget for the archivist but this is for expense to cover my costs and stationery such as the special files that we purchased etc.

For instance the donation of the engines from the States cost over £600 with import duty and the cost of the display cabinets, they have an estimated value of £5,000.

Archiving is identifying and listing items of historical value first to the S.M.A.E/B.M.F.A. and secondly to aeromodelling in general. Sounds simple, however it's not quite like that because where as some people will save everything others will dispose of everything, so a balance has to be reached based on the space you have available.

During my sorting through of the Society's papers I have found bags and bags of duplicated information which was obviously thought would 'come in handy' i.e. minutes of meeting, rule changes, membership change of addresses and also notification that members had passed away, these date back to the early nineties when we first moved into Chacksfield House.

I hope to be in discussion with David and Linda some time soon to try to establish regular housekeeping management of this type of paperwork.

I look forward to reporting in next time in May that I have moved all our archives into a dedicated room at Chaksfield House.

I have been invited to attend the Model Engineers Show, which is well worth a visit, especially if you haven't been for a while.

Bookings have started for the 2009 show season, and again this year I intend to offer what assistance I can to areas who need help with running BMFA stands. Last year this assistance ranged from a bit of remote guidance (via email), through van driving (and trailer towing), up to managing our stand at several shows. My aim again is to act as a catalyst to enable Areas to run their stands in future years with less "outside" assistance, whilst ensuring that the stands run on behalf of the BMFA project a professional image worthy of our society.

To this end, a couple of new tables have been purchased for use at shows, to replace the pasting tables. Whilst more expensive than pasting tables, they should be easier to work with (they're blue, with velcro on "curtains" to hide stock stored under the table), we'll see how they work in practice.

I'm sure most volunteers who help on stands at shows will, at some stage, have been approached and asked "why isn't there a picture of my aspect of the sport ever displayed on a BMFA stand?". I was very impressed last year at how slickly the advertising side of the PRO work was executed by the office. We produce copy inhouse now, and the whole process is very well run. I was approached a couple of times for some additional coverage for specific events, which I was delighted to assist with, but if you have ideas about where we should be advertising, please do let me know.

To help with my understanding of how the society is run, I have been attending some interesting meetings. The Education Subcommittee meeting I attended last year was inspirational - so enthusiastic and positive, with a real "can do" attitude. FAI Delegates report to Council January 2009

At the Sept Council meeting I was charged to confirm Mr M Colling's FSMAE acceptance of the post of Education delegate to CIAM. I can now confirm that I have his acceptance.

I was further instructed to "sort out" the condition and whereabouts of the Jack North Trophy. Contrary to rumours it was brought back from Bulgaria on Mr Woodhouse's FSMAE knee on the aeroplane. Mike did minor repairs and cleaned the trophy prior to photographing it to show in "BMFA News". It then went to Mr Laurie Barr FSMAE who said leave it with me!! Mr Barr quoted a price of £1000 to remake/make anew box.

I understand that the London Area delegate then asked Mr M Colling to have the box remade. Fortunately, prior to the commitment of BMFA monies, I was able to tell Mike that it is an FAI trophy and the responsibility of the BMFA. The competition secretary has ascertained that the FAI is not prepared to pay for repairs or a new box. *Presumably they believe it to be the responsibility of the Bulgarian NAC.*

It has now transpired that the two previous winners of the trophy have not had it appropriately inscribed .

I believe that Mike Colling has returned the Trophy to Chacksfield House, and I suggest that the trophy be engraved to show the UK as winners in 2008, this at BMFA expense. The trophy can then be handed over at the next World Champs to the organising country.

I can now confirm that the 2009 CIAM will be held at the Olympic Museum, Lausanne on the 27th & 28th March 2009.

ROYAL AERO CLUB DELEGATE'S REPORT - January 2009

At the RAeC Council meeting, preceded by a meeting of the Medals & Awards Committee, the following matters may be of interest to Council.

- 1) I am glad to report that I was successful with all our nominations for RAeC awards; accordingly the following presentations will be made at the Awards Evening, the date of which has been fixed for April 21st. Venue and guest are to be announced later.

RAeC Bronze Medals – Dave Clarkson and Bill Draper; RAeC Certificate of Merit – Lindsey Smith; Rolex Trophy – Aislinn & Eilidh Price

I would ask that the date of the Awards evening, along with the recipients, be announced in the next BMFA News, in order to give people time to book tickets and note the date.

- 2) A tender for the newly-designed RAeC website is to be received before Feb. 28th. One of the points seen as vital for the new site is that it should be able to be up-dated on a daily basis in order to be of value.
- 3) A design for the new RAeC record certificates that associations will be able to use was shown and will shortly be available.
- 4) There is a possibility of a meeting between RAeC associations' CEOs and the Department for Culture, Media and Sports.
- 5) Associations are asked this year to invite members of NADFAS, who are doing extensive archiving of historic RAeC documents and photographs at Hendon, to their major events as v.i.ps. Jim Crocker should be contacted in this connection, and will be able to pass on the invitations to the relevant people.
- 6) The present RAeC secretary, Diana King, is planning to retire or at least reduce her workload. She has been invaluable to the RAeC and the preferred option is for the routine part of her work to be taken on by an association's office. I have asked David Roberts to liaise directly with Dave Phipps on this matter.
- 7) In order both to be accepted in FAI events and also to be considered for any sort of funding or assistance from UK agencies and authorities all associations are advised to accept the principles of the World Anti-Doping Agency, WADA. The FAI has a draft of its anti-doping rules, which runs to 39 pages; I have passed this to the CEO, along with a useful paper by Diana King on its interpretation. It appears that some airsports may benefit from some drugs, e.g. aerobatics and parachuting, for which beta-blockers have been used to steady nerves. Other airsports people, e.g. hang-glider pilots, appear to have a greater likelihood of using recreational drugs, and there has been some testing last year at some events in Europe.
- 8) Due to the recent decline in value of sterling against the Euro and other currencies (we don't seem to be hearing much from the Say No to the Euro fraternity of Little Englanders lately...!) the Europe Airsports and FAI fees are likely to increase for us by around 30%.

Education Working Group Report BMFA Council 10th Jan 2009

As you know I have sent my permission to be absent as I am on the BMFA Education Stand at the Association of Science Education Annual meeting this year held at the University of Reading. This is the best place to come in to contact with up to 5,000 science educators of all levels. I was also absent from the Society's AGM as I was running the BMFA stand at the D & T Show at the NEC.

It has always been the aim of the Education Working Group to promote model aircraft building and flying as a good educational tool for both Craft Design & Technology and Science.

On the Sunday after the AGM myself and Terry Rounce, London Area, attended an aviation Education Conference at Brooklands Museum. This was supposed to be a follow on from a similar event held in March last year. Although all those attending were doing a great job. I was a little bit disappointed that all but ourselves were catering for youngsters that were already in organisations such as Scouting or ATC and that most of the work was centred around the 'Home Counties'. Most of the organisations present were running a small number of events and usually for a small number of youngsters. However it was important for the BMFA to be there to show that it is possible to fly without leaving the ground.

At the D&T Show we launched the BMFA's new Education models, the BMFA Arrow and the BMFA Vulcan. These models are now in full production. The BMFA Arrow has already found one unusual supporter in that the Aviation and Mechanical Engineering Department of Strathclyde University is using the Arrow as a basis for students to experiment with the reduction of structural weight to improve performance. This model proving better than either the Dart or the Gyminnie Cricket for what they require.

The Education Programme will reach two milestones this year, firstly it will be twenty years since the Education Committee (Working Group) was formed and secondly we will reach the one hundred thousandth BMFA Dart built (I have just worked out that this actually happened in May last year). To celebrate these achievements a special limited edition pack of six different Darts in one box is to be made available only through the BMFA and are now in stock at the office. The Celebration Dart Pack will be limited to 100 boxes and will include versions not normally available to the general public.

Total production of education kits has reached 204,177 of which 106,505 are BMFA Darts. It may be interesting to note that 45% of all production is sold by the BMFA Office, 28% of production goes directly to schools, 24% of production goes directly to youth organisations and the remaining 3% to private individuals.
